#### **Opportunities for improvement:**

Facility inspection and maintenance is a strength...however we can probably improve on training and practices.

- Are supervisors and managers trained/knowledgeable about the H&S risks and procedures for their departments and locations? Know the job, the risks and the law.
  - Follow up and consistency once staff have been trained (how are H&S measures being followed)
- More feedback from staff – anonymous surveys
- Reports on incidents, and “near misses” – kept in one central location (Main office)
- Fire drills – should there be one central person that all supervisors report to? How do we know if everyone is out of the building? Does everyone know their role depending on who is in the building?
  - Book of all MSDS sheets that we can give to fire dept
  - Have considerations been made for adults who need assistance?
- Identified high risk area – potential violence from youth/community members (everywhere, but particularly priority communities) – are staff adequately prepared/trained?
